CONCLUSION

This chapter presents the summary of the main points that have been discussed in the previous chapters and some suggestion that might be useful for the people who deals with the Sociolinguistics, especially the ones who are doing some research on swear words.

5.1 Conclusion

This study examines the use of swear words uttered by the students of SMUK Ign. Slamet Riyadi Bojonegoro during their informal conversations. This study also tries to describe what is the main factors that cause the students to use swear words in their conversation and what words are usually employed as swear words. Both of those questions are answered based on the theories of Sociolinguistics covering style of speech, power and solidarity, taboo words, and swear words.

To gain the data needed for her study, the writer uses a tape recorder, a cassette and a notebook. By using those instruments, the writer has chosen four conversations recorded in real conversations. The gained data then are transcribed and analyzed under the given parameters (such as the participants, the setting and scene, the topic, the way they do the conversation). As a result, the writer finds out that:

- I. The swear words that are mostly uttered by the students in their conversations are diancuk, diamput, edan, gendheng, and picek.

II. The main reasons for the students to use swear words in having conversations are:

1. The participants are mostly male
2. They are classmates
3. The topics are daily topics
4. The settings are in the canteen and classroom during the break
5. The addressee feels amazed toward to the speaker's utterances
6. They show intimacy
7. They feel desperated
8. They get angry
9. They want to show their annoyance
10. The students got dissappointed


5.2. Suggestions
