

Chapter V

Conclusion and Suggestions

In this chapter, the writer presents the conclusion of the research. The writer will also provide suggestions that will further future research that others may take regarding the same topic.

5.1. Conclusion

There will always be conflict in stories and in our lives. Conflict is triggered only when there is a reason. Conflict can occur in many different ways and have different causes. However, in the case of *Beauty and Sadness* conflict was caused by three major points and they were: sad experience, jealousy, and a broken heart. Every conflict will eventually get resolved. However, the resolution for each conflict may differ and the result may not always be a happy ending.

5.1.1. External Conflicts (Man vs Man)

The external conflicts in *Beauty and Sadness* mostly occurred in Otoko and three other characters who were involved heavily in the story. The first was between Otoko and Oki. This is without a doubt the beginning of the conflicts that occur in the story. The affair that they had, which led to the death of their baby, is the first step of the many conflicts that occur in the novel. Oki did not want to take responsibility for his actions and as a result Otoko was left alone and forever scarred. The second conflict was between Otoko and Keiko. Out of jealousy that Otoko was still in love with Oki,

Keiko took it upon herself to avenge Otoko's past by seducing Oki and making him powerless and also by killing his son, Taichiro. This conflict is the most intense conflict between two characters in the novel. And the last is the conflict between Otoko and her mother. Otoko's mother only wanted what is best for her daughter; she insisted that Otoko should forget Oki altogether and move on from him. However, deep down Otoko could not let Oki go and after their separation, Otoko was an empty husk.

5.1.2. Cause of the conflicts

There were three causes to each of the three conflicts. The first one was Oki did not take responsibility for his actions. As a man Oki should have taken responsibility for his actions, if Oki were to take responsibility for his actions and marry Otoko or at least tried to save his baby, Otoko would not be in such a mess. The second cause of the conflict was jealousy. Keiko was very jealous of the fact that Otoko still loved Oki and she wanted to take revenge. This action led to the conflict between Otoko and Keiko. And lastly, the cause of the conflict between Otoko and her mother was the fact that Otoko did not want to move on from his past lover, Oki. This made Otoko's mother very sad and depressed. Otoko's actions of not moving on brought a major conflict with her mother.

5.1.3. Resolution of the conflicts

For the first conflict, the resolution of the affair between Otoko and Oki was a final separation.
